The Tehachapi-Cummings County Water District is offering one (1) 2004 Chevrolet pickup and one (1) 2007 Chevrolet pickup for sale to the highest bidder. There are bid minimums on each vehicle listed below. Bids will be sealed and not opened until the referenced deadline. Sealed bids must be clearly identified and received in the District office before the deadline. If a bid is received after the deadline the submission will not be considered. Bids will be opened and reviewed by the General Manager at the District office located at 22901 Banducci Road, Tehachapi, CA at the date and time stated.

Buyer(s) will be responsible to remove the equipment from District property at buyer's expense within 10 calendar days following acceptance of the bid. Buyer(s) will be required to remove the pickup(s) in a manner acceptable by the District. If the District deems the proposed method of removal unacceptable the buyer will complete its removal and transport in a safe manner, subject to acceptance by the General Manager. Buyer will be required to provide proof of insurance subject to approval by the District before removing the equipment from District property.

In the event of a tie, bidding will be reopened to selected bidders at the sole discretion of the General Manager. Bidders will be invited to re-submit a new bid by a date and time to be determined by the District and awarded to the highest bidder.
